## Dominica Citizenship by Investment



The Commonwealth of Dominica offers a Citizenship by Investment program that allows foreign applicants and their families to obtain Dominica citizenship through one of two investment options:

- Non-refundable contribution
- Real estate investment

**Starting from:** US \$100,000

**Passport power:** 140+ visa free countries

**Eligible family members:** Spouse, children, and parents

**Taxes:** No wealth, gift, inheritance, foreign income, or capital gains tax



## Greece Golden Visa



The Greece Golden Visa is a residency-by-investment program that allows applicants to obtain permanent residency in Greece by purchasing one or more properties. Investors are granted a residence permit that can be renewed every five years, provided they maintain ownership of the properties they have purchased.

**Type of investment:** Real estate investment

**Starting from:** €250,000

**Residency permit:** 5 years, renewable

**Time to citizenship:** After 7 years of residency

**Visa-free travel:** Within the Schengen area and EU countries

**Eligible family members:** Spouse, children, and parents

## Canada Start-up Visa



The Canada Start-up Visa Program is an investment immigration pathway tailored for international entrepreneurs eager to establish startups in Canada.

Through this program, entrepreneurs can obtain permanent residency in Canada, become eligible for Canadian citizenship, and enjoy the full benefits of living and working in Canada.

**Type of investment:** Business venture

**Time to get permanent residence:** 2-3 years

**Time to citizenship:** After 3 years of residency

**Eligible family members:** Spouse and children
